1. **Aladdin Items Only:** Items produced by The Mantle Lamp Co., Aladdin Industries, AMLC, Lehman's Non Electric Aladdin and items pertaining to our Gatherings are to be submitted. Books, pictures, etc. pertaining to the character "Aladdin", or non-Aladdin shades on lamps will not be accepted nor "hybrid lamps".
2. **Limit 7 lots per Knight:** 5 lots sold at Gathering Thursday Auction plus 2 lots sold with reserve. Each reserve lot will pay a non-refundable \$25 entry charge, to be paid to NAALC included with this form (two sheets). A "lot" is any number of items to be sold for one money.
3. **The selling fee is 15% of the selling price, per lot, up to \$1800.00 and 10% per lot \$1801.00 and up. All fees will be subtracted from the consignor's check, to be mailed after the Gathering.**
4. **The seller assumes all liability for items mailed and displayed at the auction, also for items brought and displayed. This liability extends to execution of bid at which time the buyer assumes liability. All items are handled by advanced collectors on the auction staff and every care is exercised.**
5. **No mail bids.**
6. **No minimum, reserve bids or buy-backs will be allowed in the regular, non-reserve Gathering Auction.**
7. **Ownership of lots is not routinely revealed. The lots are given numbers.**
8. **All items will be sold as is; no returns accepted. There will be adequate time for close inspection of all lots.**
9. **The auction items will be sold in order as listed in the *Mystic Light*.**
10. **Lot stickers or tabs will be sent to the sellers to affix to their items before shipping or bringing to the auction room. Please keep a copy of the form for your reference.**
11. **Auction consignments are only available to Knights in good standing in our club.**
12. **Regular Gathering Auction items may be delivered in person or shipped at consignor's risk. Reserve lots will only be accepted in person at the auction in Jefferson City, MO.**
13. **Thursday Auction is open to the public and will pay 5% buyer's premium.**
14. **Credit cards accepted.**
15. **Return completed form to Jim & Joy Michmerhuizen (address noted above).**
16. **Deadline to submit form is June 5, 2025.**
